1. Your quotation should be sealed and accompanied with bid security of Rs. 21,500/- in shape of Bank Guarantee/Pay Order/ Demand Draft / CDR in Favor of PIEDMC from a scheduled Bank in Pakistan.
2. All procurement will be carried out as per PPRA rules 2014 (amended up to date) Single Stage One Envelope procedure and Purchase Order will be issued to the lowest evaluated responsive bidder.
3. Your bid must be valid for minimum 120 days from bid opening date.
4. Delivery Schedule should be attached with quotation and shall not more than fifteen (15) days from the date of issuance of Letter of Acceptance.
5. The price should be inclusive of all taxes, G.S.T and other levies applicable under law of Pakistan.
6. In case of delay in completion of works against given/decided schedule 0.5% of final bid /day will be charged as liquidity damage and maximum up to 10% of Work Order amount.

Scope of Work

- i. Scope of work includes Supply, Plantation and Maintenance of Plants for one Month. Dried out plants during maintenance period will have to be replaced free of cost by the supplier.
- ii. Making BIE monogram with color stones in replacement with existing grass on main entrance of Estate.
- iii. Pitting and filling of sweet soil & fixing of plants in rows along Bhalwal- Bhera Road.
- iv. Pitting and filling of sweet soil & fixing of plants on left and right side of main approach road of the Estate towards Admin Building.
- v. Pitting and filling of sweet soil & fixing of plants in median on back side of marketing office building up to junction of road # 01 & 04.
- vi. Pitting and filling of sweet soil & fixing of plants in median of road # 01 from OHWT to junction of road # 01 & 08.
- vii. Pitting and filling of sweet soil & fixing of plants in median of road # 01 from junction of road # 01 & 08 to road junction # 01 & 15.
- viii. Pitting and filling of sweet soil & fixing of plants in median of road # 01 from junction of road # 01 & 15 to road # 13-A.

Payments:

1. Payment shall be made to the supplier through cross cheque / Pay Order as per mode given below.
 - a) 70% on delivery of plants at site, against Payment invoice within 15 days of submission
 - b) 20% on Plantation.
 - c) 10% after completion of maintenance period of One month.
2. Sealed financial bids shall be received in **Office of the Project Director, Bhalwal Industrial Estate, Bhera Road, Bhalwal** on or before **28th April, 2023**, by 1100 Hrs and will be opened on same day at 1130 Hrs in the presence of bidders or their representatives.
3. The work will be awarded on Least Cost Basis after the evaluation of Bids.
